WHY THIS INFORMATION

In accordance with EU Regulation 2016/679 (henceforth the "Regulation") this page describes the methods of processing of personal data of users visiting the websites of Master Training srl (henceforth "Master Training") accessible electronically at the following addresses:

DATA CONTROLLER

Following consultation of the sites listed above, data pertaining to identified or identifiable natural persons may be processed.

LEGAL BASIS FOR PROCESSING

The collection of web user data is justified by Master Training's legitimate interest in the improvement of its own website.*

TYPES OF DATA PROCESSED AND PURPOSES OF PROCESSING

Browsing data

During their normal use, the computer systems and software procedures used to operate this site acquire certain personal data whose transmission is implicit in the use of Internet communication protocols.

This category of data includes the IP addresses or domain names of the computers and terminals accessed by users, addresses of resources requested in URI/URL notation (Uniform Resource Identifier/Locator), the time of request, the method used to submit that request to the server, the size of the file obtained in response, the numeric code indicating the status of the response given by the server (successful, error, etc.) and other parameters concerning the operating system and software environment of the user.

These data are necessary for the use of web services, and are also processed for the purposes of:

•obtaining statistical information regarding the use of those services (most-visited pages, number of visitors by time block or day, geographical location of origin, etc.)

•monitoring the proper functioning of the services offered.

Browsing data persists according to the ${\sf GOOGLE}$ supplier's time frame.

Data communicated by the user

The optional, explicit and voluntary sending of messages to MasterTraining contact addresses, as well as the compilation and submission of forms present on the Master Training websites, involves the acquisition of the sender's contact data necessary for response, along with any personal data included in the communication.

Specific information shall be published on the pages of the Master Training sites intended for the provision of certain services.







Cookies and other tracking systems

Cookies are not used for user profiling, nor are any other methods of tracking used.

Session (non-persistent) cookies however are used, in a manner strictly limited to what is necessary for secure and efficient navigation of the sites. The storage of session cookies in terminals or browsers is under the user's control, while on the servers, at the end of HTTP sessions, information regarding cookies is recorded in the service log. More detailed information is provided in the "cookie policy" section.

DATA RECIPIENTS

The following subjects designated by Master Training, in accordance with Article 28 of the Regulation, are the recipients of the data collected following consultation of the sites listed above.

The personal data collected are also processed by the Master Training staff, who act on the basis of specific instructions provided regarding the purposes and methods of processing.

RIGHTS OF THE DATA SUBJECT

The data subject has the right to obtain from Master Training, in the cases provided for, access to personal data and the rectification or cancellation of the same, or the limitation of the processing that concerns them, or to oppose their processing (artt. 15 et seq. of the Regulation). THE RIGHT TO FILE A COMPLAINT

Data subjects who believe that the processing of personal data referring to them and carried out through this site is in violation of the provisions of the Regulation have the right to file a complaint with the Data Protection Authority as provided for by art. 77 of the Regulation itself, or to take appropriate legal action (art. 79 of the Regulation).
